African Womens' Development Fund (AWDF) in Ghana. The trio collectively managed to host over three hundred participants from different parts of the world in a bid to promote the spirit of giving, and particularly local philanthropy.

During the assembly's official opening, the guest of honour, H.E Ambassador Gertude Mongella from Tanzania reminded philanthropists not to always think of offering their surplus as a giving - but go beyond it - by giving what their neighbors really need.

"The spirit of giving is primarily African. Let's embrace it so as to be able to serve the vulnerable groups in communities," she reminded.

and Practice" sought to unearth good practice through knowledge building, research, experience sharing and skills building in each of these critical areas. The program foregrounded contributions to philanthropy in Africa by critical constituencies such as women, youths and other marginalized groups. This exciting action focused program has gone down in history by bringing together thought leaders, practitioners, academics, the media and other key actors to the table in Arusha, Tanzania for the first time.

The assembly conference also culminated in the Second AGN African Philanthropy Award Gala, which recognized and celebrated outstanding contributions to philanthropy on the continent.

At the awards, Kagiso trust based in South Africa emerged the winner in the category of the Philanthropy Organisation of the year while Mr. Akwasi Aidoo of West Africa became the Individual Philanthropy category winner.

More to her pedigree, she was at the helm of the fourth world conference on women held in Beijing China between 1993 and 1995. She therefore shares her great insights on the broader perspectives of philanthropy, the spirit of giving and more. Read on...

Question: How do you personally view the concept of philanthropy?

Answer: Philanthropy is a concept and practice embedded in African cultures and traditions. In many ways it is purely African.

Question: Is it a new concept in Africa, to be learnt and adopted?

Answer: It is absolutely not a new thing in Africa, and particularly here in Tanzania. Through philanthropy both the givers and receivers have dignity and respect in society. Lets remember that giving and sharing is very African. We give at every moment and stage of our lives, at birth, celebrations, weddings, funerals, rituals etc. Generosity to neighbours, friends, relatives and (foreigners) is very visible and embedded in our daily lives.

Question: Does the concept of

philanthropy and the spirit of giving borrow from any other specific notion, practices in African?

Answer: Yes indeed. In Africa there is a common philosophy of *UBUNTU*, which is based on giving and believing that "You are because I am and I am because you are". So in this AGN assembly, these are the kinds of issues we ought to emphasize and embrace when we go back to our local communities.

Question: How do you really describe the spirit of giving?

Answer: You give out what you really need in case your neighbor needs it the most, yet the receivers' dignity is enhanced.

Question: Last but not least, what is your opinion on convening such

a big philanthropic assembly, which was initially scheduled to be held in Accra Ghana, but owing to the outbreak of but the Ebola epidemics in the region it was then postponed and moved to Arusha?

Answer: This is a very good course! My special thanks go to the African Grant-makers Network (AGN) Secretariat; the Foundation for Civil Society (FCS) and the African Women's Development Fund (AWDF) for convening such a thoughtful assembly. It will enable leaders in philanthropy, practitioners, academia, the media and other key actors to join the conversation and participate in action - oriented sessions. It will also enable discussion on strategies, which will contribute to sustainable, just and peaceful development in Africa through philanthropic engagement.

FCS conducts information sessions to its grantees, CSO sector

The Foundation for Civil Society (FCS) has conducted countrywide information sessions to its grantees and other members of Civil Society Organisations (CSOs) in different parts of Tanzania - with the aim of keeping the latter abreast of developments within the FCS, and forge ahead together.

The information sessions begun on 8 July and effectively ended on 17 July after having reached various members from hundreds of civil society organisations in different parts of the country.

Key issues raised during the information sessions included updates on the FCS leadership transition - such that after a competitive process in March 2015, Mr. Francis Kiwanga succeeded the retired FCS Executive Director, Mr.

John Ulanga, who had successfully completed his tenure of office.

Also, an account was given on the new FCS Strategic Plan alongside its new thematic areas. The last issue communicated was the apparent FCS Board of Directors' decision to terminate all the on-going projects that were deemed as long overdue - with an exception of all CSO capacity strengthening interventions, and other special projects conducted through funds from the ILO, IRC (Wekeza), and EQIPP. Projects on People with Disability (PwDs) engagement in the 2015 elections will also remain intact.

Apparently, during the info sessions, a new call for grants applications was also announced - seeking to work with CSOs on

peace maintenance drive, as well as inspiring the youths, women and other special groups to engage effectively in the upcoming general elections.

The last issue communicated was the apparent FCS Board of Directors' decision to terminate all the on-going projects that were deemed as long overdue - with an exception of all CSO capacity strengthening interventions, and other special projects conducted through funds from the ILO, IRC (Wekeza), and EQIPP.

Some Civil Society Organisation (CSO) stakeholders have praised the decision by the Foundation for Civil Society (FCS) on reaffirming its position to continue building CSOs capacity in Tanzania, arguing that the move is still pertinent, and highly needed.

The remarks was raised by the chair of Jukwaa la Katiba Tanzania (JUKATA) Mr. Deus Kibamba, on 8 July at an information session conducted by the FCS to its grantees and other members of civil society organisations in Dar es Salaam.

The matter ensued in the wake of the FCS Executive Director, Mr. Francis Kiwanga, unveiling the earlier decision made by the FCS Board of Directors to terminate all on-going projects that were deemed as long overdue. It was

further said the decision would thus not apply for all CSOs capacity strengthening interventions, as well as other special projects conducted through funds from the ILO, IRC (Wekeza), and EQIPP. Also, projects on People with Disability (PwDs) engagement in the 2015 elections remained unaffected.

“The level of CSOs capacity in this country is still not good enough. I encourage the FCS to continue investing in this area as earlier pledged,” said Mr. Kibamba flanked by other participating stakeholders during the session.

FCS builds CSOs capacity through tailor-made trainings

The Foundation for Civil Society (FCS) has yet again enhanced the capacity of Tanzanian civil society organisations (CSOs) by offering four tailor-made training modules to a total of 112 participants from its grantees based in different parts of the country.

As part of the on-going capacity building program to CSOs, the tailor-made trainings took place in Dar es Salaam from 3 – 6 August 2015 and were conducted by own FCS staff, except two other co-facilitators who were invited to bring in their well-rounded gender perspective expertise.

The grantees were thus taken through four types of modules including: Organisational Development, Financial Management, Gender

The grantees were thus taken through four types of modules including: Organisational Development, Financial Management, Gender Mainstreaming and the concept of Monitoring & Evaluation (M&E).

Mainstreaming and the concept of Monitoring & Evaluation (M&E). The choice of these modules and training participants was a result of the Training Needs Assessment and the call for training applications availed to grantees since the beginning of this year, 2015.

Out of the modules, the M&E session had sought to help the FCS grantees capture their results better while concretizing them with real examples, whereas the Financial Management module sought to sharpen grantees' quality of financial reporting as per the FCS guidelines. The Organisational Development on the other hand sought to enable CSO participants attain a change of mindset towards their own organisational sustainability, governance, and

others.

Speaking of the training, a representative from Community Development Agenda Countrywide (CDAC) based in Kibaha, Mr. Bumija M. Senkondo, spoke highly of the M&E module - saying that it has helped him and his organisation attain new skills on how to rephrase better and realistic project indicators that are easy to work on, and reflective of intended project results as never before.

CSOS CAPACITY STRENGTHENING

CSOs rate their capacity, direction after FCS tailor-made training

Some members of the Civil Society Organisations (CSOs) in Tanzania have undertaken a critical analysis of their own organisational development after gaining new insights following their participation in the tailor-made training conducted by the Foundation for Civil Society (FCS) in early August 2015.

Speaking during a break after attending the Organisational Development training module in Dar es Salaam on 5 August 2015, the coordinator of Mtandao wa Vikundi vya Wakulima Tanzania (MWIWATA) Mkuranga branch, Abraham Saleem, said as CSOs stakeholders they have seen growth in the sector in terms of execution of funded projects but deep inside their internal organisational structures, there is still a lot that needs to be fixed.

ENHANCING ENGAGEMENT IN 2015 ELECTIONS

FCS trains 104 CSOs ahead of implementing 2015 Election projects, peace dialogues

The Foundation for Civil Society (FCS) has offered the Manage Your Grant (MYG) training to a total of 104 Civil Society Organisations (CSOs) that have been funded to implement projects related to enhancing citizens' engagement in the 2015 Tanzania General Elections, as well as conducting peace dialogues.

The 104 FCS-funded CSOs are expected to reach out to a million of Tanzanians in different parts of the country as well as inspire democratic engagement in the electoral processes. Critical constituencies, including People with Disability (PWDs), women and youths are expected to be part of the key targeted direct beneficiaries.

According to internal FCS procedures, all grantees have to first undergo the mandatory MYG training so as to enable them

fine-tune their project indicators, expected outcomes, as well as budgets. Also, the MYG allows the grantees to prepare plans of action for activities as well as monitoring and evaluation tools to ensure results are well captured.

Giving his opening remarks, the FCS Executive Director, Mr. Francis Kiwanga appealed to the grantee organisations to ensure that they devote their energy to adequately achieve their set out targets of enhancing effective citizens' engagement in the upcoming Tanzania General Elections, as well as peace dialogues - without any forms of diversion.

Towards the end of MYG training representatives of the grantee organisations were tested on their training modules proficiency, such that upon successful completion, they were made to sign contracts for the immediate implementation

of the funded projects.

The MYG training modules were held in Dodoma and delivered by own FCS staff members from 21-23 September.

Deadline for this call for proposal was on 31st July 2015.

The 104 FCS-funded CSOs are expected to reach out to a million of Tanzanians in different parts of the country as well as inspire democratic engagement in the electoral processes. Critical constituencies, including People with Disability (PWDs), women and youths are expected to be part of the key targeted direct beneficiaries.

Dr. Tenga re-elected as FCS President, as Prof. Ngowi is new Board chair

The FCS President's main responsibility includes chairing the meeting of the Members of the Foundation, including the AGM and any other extraordinary meetings.

The Annual General Meeting (AGM) of the Foundation for Civil Society (FCS) that was held in Dar es Salaam on 18 August 2015 has re-elected Dr. Stigmata Tenga to continue serving as the President of the FCS for another term of one year until the next AGM in 2016.

The FCS President's main responsibility includes chairing the meeting of the Members of the Foundation, including the AGM and any other extraordinary meetings.

"We will in due course appoint a new FCS Member to fill up one vacancy left following the demise of Mr. Amritlal Shah that took place towards end of last year," said the FCS Member, Mr. Alais Morindat, while unveiling news of the re-election of Dr. Tenga as the FCS President.

The Members also unanimously resolved to appoint Prof. Honest Prosper Ngowi as the new Chairperson of the FCS Board of Directors for a period of one year until the next Annual General

Also during the AGM, the Members received and approved the FCS Annual Report and Audited Financial Statements for the year 2014, and re-appointed KPMG as external auditors of the Foundation for 2015.

There are three different levels of governance at the Foundation for Civil Society. These are the Members, the Board of Directors and the Secretariat. As per Memorandum and Articles of Association of the FCS there are between five and seven Members at a time and these are headed by a President elected by themselves and they are selected on the basis of their commitment to the civil society sector, interest and integrity. The Members exercise their authority mainly through the Annual General Meeting or extraordinary meetings.

The current Members are Dr. Stigmata Tenga, Mr. Alais Morindat, Mr. Rakesh Rajani, Prof. Samuel Wangwe, Ms. Mary Rusimbi and Mr. Salum Shamte. Dr. Tenga's was first elected as FCS President in 2010.

The Board of Directors is the second principle organ of the FCS. It is a Governing Board providing regular oversight of the activities of the Foundation.

The Board's role include: approving any changes to the structure of the FCS, approving higher level policy and changes or additions to high level rules, regulations and procedures of the FCS, providing final approval of annual plans and budgets for endorsement at the AGM, review and discussion of the financial report with the auditors and presenting audited financial statements for approval by the AGM, and also, the recruitment and performance management of the Executive Director.

Forum connects People with disability to engage in 2015 general elections



Here are some of the people with disability sharing a light moment during a special disability forum held in Dar es Salaam in early September aimed at strengthening their participation in the 25 October 2015 polls. The forum was organized by the Foundation for Civil Society (FCS).

Some key resolutions made at the Persons' with Disability forum organized by the Foundation for Civil Society (FCS) in Dar es Salaam from 9-10 September seems to have propelled the special group closers towards strengthening their participation in the 25 October 2015 polls.

People with visual impairment, for their part, demanded authorities in Tanzania to ensure that their group is facilitated with thorough education on the use of tactile ballot folders ahead of the General elections.

This followed news of assurance to them that the National Electoral Commission (NEC) has already responded to their demand of making 'tactile ballot' folders available at polling centers on the election day.

This is the first time NEC introduced the special ballot

folders for the visually impaired persons. In past elections, they were assisted to vote by relatives or friends, whom they say sometimes, misguided them to vote for candidates not of their choice.

Speaking at the forum the secretary general of Tanzania Federation of Disabled People's Organisations (Shivyawata) Mr Felician Mkude said, "Before the end of September, NEC will provide samples of tactile ballot papers for us to start practicing before October elections."

And this indeed happened, thanks to their engagement as facilitated by the FCS.

Shivyawata had also been working with the NEC to map mapping areas where the visually impaired people will vote so that the papers could be allocated and distributed accordingly.

The PwDs also requested as per their engagement with NEC to ensure smooth voting exercise the special group.

The good news is that there has been positive progress by NEC whereby according to the NEC Chairman, Rtd Judge Damian Lubuva, on voting day, the PwDs will be given priority so that they vote immediately upon arrival at polling centres.

"We will ensure that they do not line up in long queues when they turn up for voting and already we have directed all returning officers to lead them in the rooms whenever they see them," he said.

This wraps up one of key Persons' with Disability forum outcomes, such that over 130 people with disabilities had earlier on met to discuss how to strengthen their participation in the October 25 polls.

People with disability decry allegedly 'stigmatizing language'



Various messages including those in the form of sign language, like this one here, became so loud and clear depicting the people with disability condemnation of any sort of allegedly stigmatization. This all took place in the disability forum held in Dar es Salaam in early September, organized by the Foundation for Civil Society (FCS).

Some people with disability in Tanzania have decried the allegedly use of 'stigmatizing language' directed to them during campaign trails that have been taking place all over the country ahead of the 25 October 2015 General elections.

Speaking at the fourth Persons with Disabilities' forum organized by the Foundation for Civil Society (FCS) in Dar es Salaam from 9-10 September to discuss how to strengthen the special group's participation in the October 2015 elections, some participants wanted authorities to intervene immediately so as to rescue the situation.

Making his contribution at the forum a member of Tanzania Albino Society (TAS) Tabora region, Ramadhan Nassor, said he is an eyewitness that some contestants with disability have been stigmatized based on their disability.

"I have seen a contestant with disability been stigmatized quite openly. His opponents simply appealed to citizens not to vote for him since he is a blind man – who can't even visualize the road that the former was advocating for its rehabilitation"

"I have seen a contestant with disability been stigmatized quite openly. His opponents simply appealed to citizens not to vote for him since he is a blind man – who can't even visualize the road that the former was advocating for its rehabilitation," lamented Nassor.

Nassor thus called upon authorities to ensure a level-playing field is availed to all contestants in the political campaigns without stigmatizing ones' disability.

The theme for this year's disability forum was on "increasing the PwDs engagement in the upcoming General Elections in October". Over 130 people with disability attended the forum organised by the FCS.
